Article 1 - Entity Name and Type.

The filing entity being formed is a nonprofit corporation. The name of the corporation is EAL Holding Corporation.

Article 2 - Registered Agent


Article 4 - Membership

The corporation is to have no members.

Article 5 - Purpose

The nonprofit corporation is organized for the following purposes:

- To operate exclusively for charitable, educational, religious, or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States internal revenue law) (the "Code");
- To operate under Section 509(a)(3) of the Code (or the corresponding provision of any future United States internal revenue law) exclusively for the benefit of, to perform the functions of, or to carry out the purposes of Travis Central Appraisal District; and



3. Subject to and within the limits of above purposes, the corporation will lessen the burdens of government by acquiring, holding title to, borrowing money for the purchase of, and collecting income from property for the exclusive henefit of Travis Central Appraisal District.

Notwithstanding any other provision of this Certificate of Formation, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by any organization exempt from taxation under Section 50l(c)(3) of the Code and its Regulations as they now exist or as they may hereafter be amended, or by any organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended. In addition, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by a supporting organization under Section 509(a)(3).

The corporation shall function as an organization qualifying under Sections 50l(c)(3) and 509(a)(3) of the Code.

The corporation is not empowered to support or benefit any organization other than Travis Central Appraisal District.

Article 6 - Dissolution

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all the liabilities of the corporation, distribute the assets of the corporation exclusively to Travis Central Appraisal District, or if the Travis Central Appraisal District shall not then exist, then the assets shall be distributed exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Code, as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as such court shall determine, which are organized and operated exclusively for such purposes.

Article 7 - Effectiveness of Filing

This document becomes effective when the document is filed by the secretary of state.
