On January 25, 2010, the Nationwide Mortgage Licensing System (NMLS) launched their Consumer Access website. Similar to our department's RMLO search page, the NMLS Consumer Access allows the public to view licensing/registration information on mortgage companies, branches, and individual loan originators. It is important to note that only those currently licensed through the NMLS are in the website, therefore our department's licensee population will not be searchable until we have transitioned. You may also find this tool useful when researching companies/individuals who also operate in other states. Click the button on the left to navigate to the NMLS Consumer Access.
