

The Undersigned Affiant, who after being duly sworn by me, on oath,  
makes the following statement:

I HAVE GOOD REASON TO BELIEVE AND DO BELIEVE THAT LEWIS CONWAY, BM  
4-4-70, DID ON OR ABOUT THE 1ST DAY OF AUGUST, COMMIT THE OFFENSE OF  
ASSAULT WITH INJURY. MY BELIEF IS BASED ON INFORMATION PROVIDED TO ME  
BY SHELTON SMITH WHO LIVES AT 10101 WARRINGTON COVE IN AUSTIN, TEXAS.

SMITH TOLD ME IN A SWORN STATEMENT THAT HE WAS SITTING ON A BUS-STOP  
BENCH AT 6TH AND CONGRESS IN AUSTIN, TRAVIS COUNTY, TEXAS, WHEN THREE  
MEN WHO HE USED TO ATTEND SCHOOL WITH WALKED UP TO HIM. ONE OF THEM  
ASKED IF SMITH REMEMBERED THEM, AND SMITH SAID HE DID. AT THAT, CONWAY  
STRUCK SMITH IN THE SIDE OF THE HEAD WITH A CLUB AND DAVID ARNOLD  
GRABBED SMITH AND HELD HIM DOWN SO THAT HE COULD NOT STAND. WHILE HE  
WAS BEING HELD BY ARNOLD, "CHANEY", THE THIRD SUBJECT INVOLVED, STRUCK  
SMITH IN THE SIDE OF THE FACE WITH HIS FIST.

I OBSERVED AND PHOTOGRAPHED A LARGE SWOLLEN KNOT ON THE LEFT SIDE OF  
SMITH'S FOREHEAD ABOVE THE LEFT EYE. HE ALSO COMPLAINED OF PAIN TO THE  
LEFT JAW.



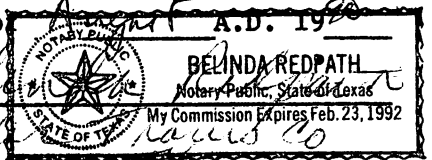
