Executive Summary

This report looks at contributions from Austin residents by zip code made to candidates for Austin City Council during 2016-17, and assesses the contribution power of each zip code by comparing the share of total Austin resident council candidate contributions for each zip code to the population share for each zip code.

Contributions to council candidates were received from 43 Austin zip codes, but a few affluent zip codes give far more in contributions than others. Three wealthy West Austin zip codes together produced a total of almost \$400,000, or 44% of all contributions from Austin residents. The top 10 zip codes produced 71% of contributions, although they contain only a quarter of Austin residents. The remaining 32 zip codes, containing three-fourths of Austin's population, produced only 29% of Austin contributions. The bottom 10 zip codes produced only 1% of contributions. Adjusted for population, the top zip codes gave more than 50 times the contributions per capita than the bottom zip codes.

Donors with addresses within the City of Austin accounted for 82% of all contributions to Austin council candidates.

Three Austin zip codes (78731, 78703 and 78746) each produced more than \$50,000 in council contributions. These zips together produced a total of almost \$400,000, or 44% of all council contributions.

Seven zip codes (78701, 78750, 78704, 78756, 78759, 78757, and 78702) each produced City between \$20,000 and \$50,000 in council contributions. Together, these zips produced over \$250,000 in council contributions, almost 28% of total council contributions.

The 10 top zip codes produced 72% of all council contributions, although they contain only a quarter of Austin residents. The remaining 33 Austin zip codes, containing three-fourths of Austin's population, produced only 28% of contributions.



Next, an index value was calculated for each zip code by dividing each zip code's share of total Austin donor contributions by the zip code's share of Austin population. This approach weights each zip to take population into account.

This perspective produces similar results: Zip codes with an index value over 1.00 have greater than average contribution power; those with an index value under 1.00 have lower than average contribution power. Zip codes with an index value over 1.00 contain a quarter of Austin's population, but produce 77% of Austin council contributions.


