## Link to Pierce County Library's policy.

Supporters of petitions may solicit signatures on library property, but not within the library building because of space limitations. Signature gatherers must not interfere with pedestrian or vehicular traffic into and out of the library building. Signs may not be posted on the building. Petition supporters wishing to set up a small table (no more than 36"x36") may do so only when there is sufficient space and after receiving approval from the building supervisor.

Distribution of Literature or Obtaining Petitions at Library Buildings

## Active Distribution of Literature or Obtaining Signatures for Petitions

- 1. Literature, surveys or petitions are not to be distributed to people inside library facilities, but only on public sidewalks outside the library entrance.
- 2. Persons distributing literature or obtaining signatures for petitions must not interfere with due orderly entry to or departure from library buildings.

# **Petitioning and Electioneering**

It is the policy of the St. Louis Public Library to prohibit all campaigning, petitioning, canvassing, interviewing, survey taking, distribution of materials, photography or videotaping, soliciting or sales in library buildings and on library property without written permission from library administration. (Appropriate Use of the Library Policy adopted by the Board of Directors June 26, 2000 and Revised September 10, 2007.)

Individuals and/or organizations requesting Library permission to petition must submit their requests in writing or by email to the Deputy Director. Requests must include the name of the organization/petitioner, the reason for petitioning, the locations, dates, and times petitioning is requested, and contact information for the individual submitting the request.

St. Louis Public Library allows the circulation of petitions outside its facilities as long as this activity does not interfere with the conduct of business or impede the free access of the public to Library buildings and resources. Specifically, individuals or organizations gathering petition signatures may stand on Library property, as long as they maintain a distance of 25 feet from entrances and/or exits, do not block or interfere with customers seeking to use the Library, or otherwise disrupt Library patrons or activities. Petitioners are not guaranteed the use of an area protected from sun, heat, or inclement weather. Signs promoting petitions may not be placed on doors or buildings and petitioners must in no way affiliate themselves with the Library, either through written publicity, signage, or verbal statements. Petitioners are required to register at the Library's Customer Service Desk prior to gathering signatures.

Petitioning Inside Library buildings is prohibited. Petitioners refusing to comply with this policy will be asked to leave Library property.

Electioneering, Including the distribution of election literature and the posting of slgns, is permitted only on election days; however, any such activity is prohibited within 25 feet of polling places. (Missouri State Statute (RSMo § 115.637(18)). Noncompliance may result in a conviction for a class four election offense punishable by fine and/or imprisonment.

## MTG3 Petitions

The Salt Lake City Public Library recognizes citizens' fundamental right of political expression. As a politically neutral institution, the Library does not endorse or oppose the issues or views expressed through a petition drive.

Petitioning is not permitted inside Library buildings, including the Urban Room of the Main Library. The right to petition on Library grounds is granted through Salt Lake City Corporation's Special Events Office.

Individuals or groups wishing to petition on the grounds of any City Library must obtain a Free Expression Activity Permit from Salt Lake City Corporation's Special Events Office, 801-535-6110 or:

SUBJECT:

PETITIONING

EFFECTIVE: MARCH 1, 2018

SUPERSEDES: 5/2015

#### 1. Purpose:

A. The Tampa-Hillsborough County Public Library (THPL) allows petitioning and canvassing on library property in support of its mission of promoting an informed citizenry by providing a forum for citizens to address community needs and respond to community growth and change.

#### 2. POLICY:

- A. Petitioning, canvassing, and similar types of citizen initiatives designed to contact, survey, gather signatures, share information, and or/inform citizens about various topics are only allowed within a designated area outside the library building. No petitioning, canvassing, or similar types of citizen initiatives are allowed inside the library building. No solicitation or fundraising is permitted.
- B. The space for petitioning, or similar citizen initiatives, shall be designated by the Library Regional Manager, or designee. Requests are handled on a first-come, first-served basis, and must not impede access to the building. Organizations, groups, or individuals shall be refused space if the designated areas meeting the location requirements above have been filled.
- C. Petitioners must provide contact information for themselves and for the group for which they are working for emergency, safety, and liability purposes.
- D. Organizations, groups, or individuals are responsible for bringing their own equipment and furniture.
- E. Signs and posters cannot be affixed to the building.
- F. Sound amplification and/or other equipment cannot be used.
- G. The organization, group, or individual petitioning or conducting similar citizen initiatives is responsible for the information presented. Permission to use THPL property does not imply that THPL or Hillsborough County endorses the purposes, policies, or contents of the organization, group, or individual.
- H. Petitloners must not impede or interfere with customers' access to library facilities and are subject to the Library's Code of Conduct, LS502.

#### 3. PROCEDURE:

- A. When an organization, group, or individual sets up to petition or perform a similar action on library property, the Branch Supervisor:
  - 1) Determines whether or not the activity remains in compliance with the above THPL Petitioning Policy.

- 2) Notifies their Library Regional Manager of the contact information of the organization, group, or individual utilizing the library property.
- B. The Library reserves the right to refuse individuals, groups, or organizations space for petitioning. Refusal can be based upon, but is not limited to: 1) disruption of normal library business operations such as obstructing entrance and exit of library facilities; 2) conducting petitioning outside of normal business hours. Refusal cannot be of an arbitrary or capricious nature in accordance with this policy. Individuals, groups, or organizations may ask for reconsideration of a denial by taking the following steps:
  - The individual, group, or organization should first seek resolution from the branch or department supervisor.
  - 2) If unsatisfied with the response of the branch or department supervisor, the individual, group, or organization may complete and send an Appeal for Use of Library Petitioning Space form to the Director of Libraries requesting review of petitioning space denial. The form must be received no later than 15 days after the initial complaint to the branch or department supervisor.
  - 3) The Library Director or designee appoints a panel of three Managers to review the petitioning space denial and address the party's complaint. The panel reviews the appeal form request and any relevant policies and informs the party in writing of its decision within fifteen days of receipt of the group/organization's complaint.
  - 4) Within seven days of receipt of the review panel's decision, the party may send a letter to the Director of Libraries asking for rescission of the denial and the reasons for the requested rescission. The Director has seven days to review the panel's decision and respond to the group/organization in writing.
  - 5) Within seven days of receipt of the Director's decision, the party may send a letter to the Tampa-Hiisborough County Public Library Board requesting review of the denial. The Library Board reviews the decision at their next regularly scheduled Board meeting and informs the party of their decision in writing. The decision of the Library Board is final.

## 4. AUTHORITY:

Pursuant to Section 5 of Chapter 84-443, Laws of Florida, the Public Library Board (the Library Board) has the duty and the responsibility, among others, to serve in a recommending capacity to the Director of Library Services and to the County Administrator in respect to all matters pertaining to the Public Library System of Hillsborough County (the Library System) and library services.

Linda, thanks for copying me, along with the entire Council, on your message protesting how volunteer petitiongatherers were treated at the City's libraries. The North Village Library is in District 7.

What happened to volunteer petitioners outside the libraries is of real concern to me, given that the Austin City Charter protects residents' right to initiative and referendum. I understand, too, that no one complained about the volunteers and, in the North Village incident, the volunteers had first gone inside to advise the library manager that they would be outside and were told that they could not petition outside the library, and so they were prevented from doing so.

The "Herfurth Memo" purports to give advance direction to city library staff with regard to the IndyAustin petitioners. I'm curious how this directive actually applies since by all reports the petitioners were not inside the libraries, were not using a meeting room (although it appears that if they had reserved a meeting room then gathering signatures would be in accord with the rules and thus allowed), were not disruptive, and were not disrupting library activity. And again, at least in the North Village Incident, the volunteers were prevented from petitioning.

With this message, copied to the City Attorney and City Manager, I am requesting that staff keep me apprised of discussions and actions taken to resolve this matter.

I hope that this matter is rectified and resolved in short order.

On Saturday, February 17, Petitioners for holding a public vote on CodeNEXT were stopped from petitioning on city owned Publi improperty, specifically at a number of Austin Public Library locations. Library Mangers told these petitioners to leave the property based on a directive from Library Management. In no case did individual library Managers cite any complaints from library users, in one case, a petitioner was threatened with criminal trespass and issued a warning notice by police. These petitioners include Bill Bunch (Twin Oaks Library), Jeff Jack (Twin Oaks Library).

Scott Royder (Spicewood Library), Mark Leszkierwicz and Hannah Young (Manchaca Library), Debbie Russelli (Hampton Library) and Saira and Doug Morgan (N. Village Library).

All library managers were polite and several even expressed embarrassment about what they were directed to do – to eject obviously concerned critizens who were simply expressing their right to free speech on p blic property.

We believe the City's interference in petitioning for an initiative for adoption of a City ordinance—regardless of the content of the proposed ordinance—is without legal authority and violates petitioners' rights under the First Amendment, the Texas Constitution, and City law.

On Thursday, February 15th, IndyAustin petition manager, Linda Curtis, made a courtesy call to Laura Pollo, Assistant to Mr. Roosevelt Weeks, Director of the Austin Public Libraries. At that time, Ms. Pollio thanked Curtis and thought there would be no problem. Curtis mentioned on this call that petitioners had, in fact, been petitioning for months at the Austin Central Library without any problem or inscident. Pollio agreed.

At approximately 12:00 pm. Friday, February 16, Ms. Curtis received a call from Dana McBee who said petitioners could not be on any library property. McBee promised that a communication to Ms. Curtis and Fred Lewis, citing the ordinance or rules governing this would be shared from Ms. Herfurth's office. No such notice came to either Curtis or Lewis.

Attached is an email dated February 16th from Sharon Herfurth, the Division Manager of the City of Austin Office of Programs & Partnerships. The Herfurth memo was not forwarded to IndyAustin until after the first petit ioners being ejected – Saira and Doug Morgan – from the N. Village Library. It was forwarded to Ms. Curtis, with Herfurth's permission, by N. Village manager Michael Abramov.

Attorney Bill Aleshire represents IndyAustin—one of the groups petitioning on CodeNEXT. On Saturday, February 17, Aleshire, after reading the Herfurth memosent this note to City Attorney Anne Morgan:

Iheard about this issue this marning and wanted to contact you right away. The attached email was sent to library staff to stop my client Indy Austin from gathering signatures on their petition regarding CodeNEXT. Frankly, the wording and link in this email from Austin staff appears to indicate a content-based enforcement, targeting these particular petitioners for this particular issue, away from library potrons today. Linda Curtis, Bill Bunch, Jeff Jack, and other volunteers are at libraries, without disrupting any troffic at the entrances or aperation of the libraries inviting people to sign the petition. Of nate, they are getting a very enthusiastic response from people who like to read and go to libraries. The library customers are not only not complaining, they seem to appreciate the apportunity to sign the petition...

Also in the email, Aleshire made reference to the City Charter initiative provision, Article IV, section 1:

#### § 1. - POWER OF INITIATIVE.

The people of the city reserve the power of direct legislation by initiative, and in the exercise of such power may propose any ordinance, not in conflict with this Charter, the state constitution, or the state laws except an ordinance appropriating money or authorizing the levy of taxes...

We contend that based on the people's reservation in the Charter of this right to initiative petitioning, the Council and the City Manager lack authority, by ordinance or administrative rule, to interfere in petitioning anywhere unless the petitioning interferes in government operation or causes a threat to public safety. In other words, unlike other forms of free speech the Council may be able to restrict to reasonable "free-speech tones," petitioning for an initiative is an exception—a power reserved by the people of Austin—that the City Council and staff have no authority under the Charter to interfere with. Interiering in the people's right of petition is not a good way for the new City Manager to get off on the right foot with the public.

We request the city to cease and desist immediately to avoid further legal conflict and further violation of the rights of Austin citizens exercising their right to petition on public property. Petitioners, in all cases, were not in any way interfering with city business, soliciting, business or funding from any person, nor distributing literature or interfering with the use and enloyment of our city libraries. They shood away from entrances and were polite at all times. Even the City's official administrative rule reorgnizes that sidewalks are a "traditional public forum." Yet, the petitioners were threatened and told to leave even the sidewalk area by the libraries.

Petitioning at city libraries in a way that does not interfere with any other person's enjoyment of such property is not a criminal offense. Yet, these petitioners were removed from the area outside libraries because of what they were doing—petitioning.

We therefore ask that the CitY Manager and City Attorney take immediate steps to assure that no other petitioners are cited or threatened with citation and that any warning citation issued on Saturday, February 17 be withdrawn in writing.

SUBJECT:

Use of City Facilities to Campaign for Ballot Measures

We have received several questions recently about the use of City facilities by non-City employees to advocate for specific measures on the upcoming November election ballot. You should recall the briefing on this topic we received from the Law Department at the September 4 Department Director's Meeting. This memorandum is to confirm the City's policy on the use of City facilities, and to provide direction for how I want all City Departments to handle any issues on this topic that may arise in the future.

## 1. Our Policy

To confirm what I hope was understood by everyone during our September 4 discussion, the facilities the City owns or controls for conducting City business or providing City services may not be used for purposes unrelated to the City business or services for which those facilities exist. With the exception of some parts of the City Hall complex, the City does not permit political activities such as campaigning for or against candidates or ballot measures, leafleting, collecting signatures on petitions, demonstrating, soliciting contributions, and similar activities to take place at City facilities. These restrictions apply to all areas of a City facility, including the facility's interior, its exterior grounds, its entryways and lobbies, public reception areas, elevators, parking loss and garages, and walkways located on the property. The sidewalks adjacent to public streets around a City facility are not part of the facility, and these restrictions do not apply to those sidewalk areas.

Note that these restrictions apply equally to both City employees and members of the public. Thus, neither City employees nor the public may engage in activities at a City facility that are unrelated to the City business or services for which that facility exists, including the type of political activities described above. In addition, all City employees are specifically restricted by state law from using City facilities or resources for political activity. Thus, employees cannot hold or attend meetings at City facilities or on City time to advocate for or against any of the measures on the November ballot, or distribute materials at a City facility advocating for or against any of the ballot measures or candidates for office. City employees can most certainly engage in the political process on their own time and outside City facilities, but cannot use City time or resources for that purpose.

#### Stresses that enforcement will be content-neutral 2. Administering This Policy

Our expectation is that all Departments will manage any issues arising under this policy in an absolutely contentneutral manner. That is, you will follow our policy fairly and consistently regardless of whether you approve or disapprove of the particular political activity in question.

While our employees should already be aware that they are restricted from engaging in political activities while on City time or on City premises, your managers should ensure that the employees in your Department follow these rules just like all other applicable workplace standards. If employees are engaging in political advocacy during work time or at City facilities, managers should address the issue as you would any other conduct issue with appropriate counseling and follow up.

With respect to political campaigning activities by non-employees, Department Directors should work with our Building Services Officer, Eric Stockton, to administer this policy in a fair and consistent manner across the City. Managers who become aware of such activities by non-employees in your work areas should ascertain the name of the individual(s) and ask the individual(s) to leave the facility immediately. Your approach should be to address the improper activity directly, but also in a professional and reasonable manner without unnecessary escalation. If the individual(s) refuse to comply with your direction, then contact your building security personnel, who will handle the situation. If your managers observe violations of this policy in a common area of your facility they should immediately notify the building manager for your facility, who will handle the situation. In addition, all managers will report all instances of a non-employee in violation of this policy at your facility to Building Services Officer, Erick Stockton and the Office of Deputy City Manager McDonald immediately.

Please let me know of any questions or concerns you have about this information or about your role in administering the City's policy going forward.

All library managers were polite and several even expressed embarrassment about what they were directed to do – to eject obviously concerned citizens who were simply expressing their right to free speech on public property.

We believe the City's interference in PetitionIng for an initiative for adoption of a City ordinance—regardless of the content of the proposed ordinance—is without legal authority and violates petitioners' rights under the First Amendment, the Texas Constitution, and City law.

On Thursday, February 15th, IndyAustin petition manager, Linda Curtis, made a courtesy call to Laura Pollo, Assistant to Mr.

Roosevelt Weeks, Director of the Austin Public Libraries. At that time, Ms. Pollio thanked Curtis and thought there would be no problem. Curtis mentioned on this call that petitioners had, in fact, been petitioning for months at the Austin Central Library without any problem or incident. Pollio agreed.

Bill Aleshire is saynig that Linda Curtis called Laura Pollo, assistant to Roosevelt Weeks, and that Pollo agreed that there had been no problem with petitioners in recent months.

At approximately 12:00 pm, Friday, February 16, Ms. Curtis received a call from Dana McBee who said petitioners could not be on any library property. McBee promised that a communication to Ms. Curtis and Fred Lewis, citing the ordinance or rules governing this would be shared from Ms. Herfurth's offlice. No such notice came to either Curtis or Lewis.

Attached is an email dated February 16th from Sharon Herfurth, the Division Manager of the City of Austin Office of Programs & Partnerships. The Herfurth memo was not forwarded to IndyAustin until after the first petitioners being ejected – Saira and Doug Morgan – from the N. Village Library. It was forwarded to Ms. Curtis, with Herfurth's permission, by N. Village manager Michael Abramov.

Attorney Bill Aleshire represents IndyAustin – One of the groups petitioning on CodeNEXT. On Saturday, February 17, Aleshire, after reading the Herfurth memo sent this note to City Attorney Anne Morgan:

The attoched email was sent to library staff to stop my client Indy Austin from gathering signatures on their petition regarding CodeNEXT. Fronkly, the wording and link in this email from Austin staff appears to indicate a content-based enforcement, targeting these particular petitioners for this particular issue, away from library patrons today. Linda Curtis. Bill Bunch, Jeff Jock, and other volunteers are at libraries, without disrupting any traffic at the entrances or operation of the libraries inviting people to sign the petition. Of note, they are getting a very enthusiastic response from people who like to read and go to libraries. The library customers are not only not complaining, they seem to appreciate the apparaturity to sign the petition....

Also in the email, Aleshire made reference to the City Charter initiative provision, Article IV, section 1:

#### § 1. - POWER OF INITIATIVE.

The people of the city reserve the power of direct legislation by initiative, and in the exercise of such power may propose any ordinance, not in conflict with this Charter, the state constitution, or the state laws except an ordinance appropriating money or authorizing the levy of taxes...

We contend that based on the people's reservation in the Charter of their right to initiative petitioning, the Council and the City Manager lack authority, by ordinance or administrative rule, to interfere in petitioning anywhere unless the petitioning interferes in government operation or causes a threat to public safety. In other words, unlike other forms of free speech the Council may be able to restrict to reasonable "free-speech tones," petitioning for an initiative is an exception—a power reserved by the people of Austin—that the City Council and staff have no authority under the Charter to interfere with Interfering in the people's right of petition is not a good way for the new City Manager to get off on the right foot with the public.

We request the city to cease and desist immediately to avoid further legal conflict and further violation of the rights of Austin citizens exercising their right to petition on public property. Petitioners, I naticases, were not in any way interfering with city business, soliciting business or funding from any person, nor distributing literature or interfering with the use and enjoyment of our city libraries. They stood away from entrances and were polite at all times. Eventhe City's official administrative rule recognizes that sidewalks are a "traditional public forum." Yet, the petitioners were threatened and told to leave even the sidewalk area by the libraries.

Petitioning at citylibraries in a way that does not interfere with any other person's enjoyment of such property is not a criminal offense. Yet, these petitioners were removed from the area outside libraries because of what they were doing—petitioning.

We therefore ask that the City Manager and City Attorney take immediate steps to assure that no other petitioners are cited or threatened with citation and that any warning citation issued on Soturday, February 17 be withdrawn in writing.







The woman said that no one had told her and moved to the sidewalk. Nancy continued into the building. Later, around 5:30 p.m., Emma DeBoer-Piedt was leaving for the day and saw the same woman, again calling to people in the parking lot from her next to her vehicle, which was parked under the electric car charging station canopy. She approached Emma and Emma told her that she couldn't ask people to sign her petition on City property. The woman told Emma that she had 'spoken to the person in charge here and they said it was OK.' Emma asked If she had spoken to the Branch Manager, Kathleen Kanarski. Emma continued on, saying that City policy is that petitioning on City property is not permissible and that she would have to move to the sidewalk in the area where the political signs began. The woman said that she thought it was OK to be in the parking lot If she was as far from the building as the political signs. Emma clearly told her that she had to be on the sidewalk and could not be in the parking lot asking people to sign her petition.

Both of these are violations of both library policy and state election policies. Furthermore, you are petitioning In the street--stopping customers and voters, right where the cars are coming in and that is a big safety issue. Please move off of library property and 100 feet away from the polling place entrance."

Incident Narrative: I got a text from Ruth Kubacka stating that our neighborhood CodeNEXT petitioner was back and was adamant that she did not have to move. I went out to see where the petitioner was. It was the same woman from IR #3021. This time she was standing in the street, off the curb and approaching voters as they came out of the building. I told her that she was again on library property and that we could not allow petitioning on the premises. And that she was again, less than 100 feet away from entrance. She pointed at the street and said, "I'm off library property." 1 responded with, " You are In the street which is a safety issue and you are also less than 100 feet away from a polling entrance which is a state law. They do not allow political signs or electioneering areas less than 100 feet away from the polling location." After a bit of pushback, where she insisted that she did not have to move, I told her that I would need to call 911 If she did not move, she backed down. I directed her to the sidewalk area, where the political signs were. She complied and moved off to the area I pointed to. I then had Adrian Perez call Security to let them know that we had a petitioner near library property. They said that they would send someone over. I also checked again, about 15 minutes later to see if she was in an appropriate spot. She was behind the 100 ft markers on the sidewalk.

From that point I proceeded to speak with Jeff Rowland about our course of action at his desk. Jeff Called Dana McBee to get a better understanding of what guidance legal had for us. After speaking with the legal team Dana requested that we show the customers the City Of Austln Library Department Library Use Rules; Chapter 13 (Personal Behavior) Section A subsection 5. Dana also requested that we move forward with the issuance of a CTN B if they refused to leave. S/O Hanna and I then returned to the petitioners to provide them with the information. After briefing both parties on the rule they were breaking, they requested a copy of the rules I was reading from and I informed them they could request a copy from the City Of Austin Legal team but I could not allow them to have the copy I was reading to them from. During this time the female petitioner asked me where on the Shoal creek side of the library was off property so we walked to that side so I could show her where the property trall begins and ends. She also asked "what If we refuse to leave?" to which I responded "A CTN will be issued". I was also After showing them the information and where library

property ends/begins the gentleman refused to leave and his female counterpart agreed to leave. I proceeded with the issuance of a CTN form B to Lucas Burdick; visible on the camera Once Mr. Burdick provided me his information to fill out the CTN form B his female counterpart stated "we're here to challenge our constitutional rights to petition on public property, thank you for being polite, you've done your job well from what I can see, thank you".
