FINAL JUDGMENT

In light of the Court's prior Orders dated April 5, 2012 and July 18, 2012 on the parties' Motions for Summary Judgment and Plaintiff's Motion for Reconsideration, and the Stipulation of Attorney's Fees Between Plaintiffs and Intervenor, the Court ORDERS, ADJUDGES, and DECLARES as follows:

IT IS ORDERED that Plaintiffs' Motion for Summary Judgment and Motion for Reconsideration are DENIED.

IT IS FURTHER ORDERED that the Attorney General's Cross-Motion for Summary Judgment is GRANTED and reasonable attorney's fees in the amount of \$10,150.00 are awarded to the Attorney General.

IT IS FURTHER ORDERED that the Intervenor's Motion for Summary Judgment is GRANTED and reasonable attorney's fees in the amount of \$17,500.00 are awarded to the Intervenor. Intervenor's Motion for Summary Judgment as to the Amount of Its Reasonable



Attorneys' Fees is DENIED as moot in light of the Stipulation of Attorney's Fees Between Plaintiffs and Intervenor and this Order.

IT IS FURTHER ORDERED that all costs incurred are to be borne by Plaintiffs.

It is also ORDERED that all relief not expressly granted in this Order is DENIED.


This Final Judgment finally disposes of all claims between Plaintiffs, Defendant, and Intervenor, and is a final judgment.




