# RE: NOTICE OF POTENTIAL CRIMINAL VIOLATION & PUBLIC INFORMATION REQUEST

Dear City Officials,

Attached is the evidence that the Austin DMO, Inc. d/b/a Downtown Austin Alliance (DAA), made \$440,000 in campaign contributions with public funds to Let's Go Austin, a political action committee.

The City of Austin assesses, by ordinance, a public improvement district tax on

downtown property and pays it over, as well as additional City and County public funds, to DAA to implement enhanced public services and improvements in the downtown area. Section 3(b) of City's "management" contract with DAA provides for payments from these PID taxes to DAA within 30 days of providing a quarterly report and invoice. Section 6 of the Management Contract says:

This work report will detail all of the Contractor's significant work activities in the District.... One-quarter of the special assessment revenue to be disbursed by the City to Contractor each year will be paid within 30 days of City's receipt of this quarterly report.

Paying \$440,000 in political campaign contributions would certainly be a "significant" work activity. It will be interesting to see if the DAA blatantly discloses these contributions. But regardless of whether the DAA does so, you are now on notice that no city employee can approve reimbursement or payment to the DAA for such contributions.

The Texas Election Code makes it a crime, a Class A misdemeanor, for an officer or employee of the City to spend or "authorize the spending of public funds" for the DAA's campaign contributions.

Tex. Election Code, Sec. 255.003. UNLAWFUL USE OF PUBLIC FUNDS FOR POLITICAL ADVERTISING. (a) An officer or employee of a political subdivision may not knowingly spend or authorize the spending of public funds for political advertising.

Therefore, let this letter serve as warning to the City of Austin employee(s) who pays or authorizes payment of City funds to DAA, to pay for or to reimburse the DAA's campaign contributions, that such action may be a criminal offense.

#### **Contract Violation**

Even if it were not a criminal offense for the City to pay for the DAA's poor judgment in making such campaign contributions, it is a violation of the City's contract for DAA to use these public funds in this manner. Section 2.2 of the Management Contract restricts the purposes for which the public funds can be spent, saying, "Contractor will use the special assessments collected by the City to provide the Improvements and Services." There is nothing in the Service Plan & Budget, attached to the contract, that contains an agreement that the City will permit making political campaign contributions using the City's public funds. It is a betrayal of the taxpayers in the PID for the City to permit use of their mandatory tax for political campaign contributions. Section 21 of the contract makes it subject to all federal, state, and local laws, which would include Tex. Election Code section 255.003.

On whatever basis you choose, the City should deduct from its payment to the DAA an amount equivalent to the DAA's campaign contributions.

Please let me know within the next 10 days whether the City will voluntarily take action

to ensure that City funds, including the PID funds, are not used to pay or reimburse the DAA for its campaign contributions.

- 1. Please provide a copy of any work report or invoice for payment received since January 1, 2013 from the Austin DMO, Inc. d/b/a Downtown Austin Alliance pursuant to its Management Contract (as authorized by the City Council on October 11, 2012, and as amended).
- 2. Please provide a copy of any signed authorization for payment and record of such payment since January 1, 2013 by the City of Austin to Austin DMO, Inc. d/b/a Downtown Austin Alliance.
- 3. Please provide a copy of any correspondence (electronic or paper, whether using a City email address or personal email address) since January 1, 2014 between any officer, employee, or attorney for Austin DMO, Inc. d/b/a Downtown Austin Alliance (including, but not limited to, Charles Betts) and any member of the Austin City Council, City Manager, or City Attorney concerning, in any respect, the proposal to issue City bonds for a rail transportation project.

I agree to pay the reasonable cost of providing this information promptly and efficiently. I request the records be provided electronically in PDF format.
