Dear Mr. Davis:

Recently a review of Williamson County records was conducted by the County Attorney's Office for the purpose of determining whether or not outside counsel/attorney services for the County had been (1) approved by Commissions Court Order, (2) whether there was an executed attorney services agreement and (3) whether the services were exempted by the Commissioners Court order from the requirements of the County Purchasing Act. Upon review, it was discovered that there is not any Commissioners Court Order approving your services currently being performed for the County Court at Law Judges in the matter of Heckman, et al. v. Williamson County, et al. nor is there any approved attorney services agreement on record for any matter.

The last Commissioners Court Order regarding your employment, Commissioners Court Order/Item No. 27 of March 3, 2009, only indicates approval of your retention as "outside counsel to assist the County Attorney's Office during an employment transition for a period of 60 days..." By Commissions Court Item/Order No. 33 of August 3, 2010 (first paragraph – see Minutes excerpt enclosed) you were approved for representation of the County Court at Law Judges in the *Heckman* case with a further item/order (see the last motion/order subpart of No. 33 in the enclosed excerpt) specifically limiting your representation to the *Heckman* case and noting that the order supersedes any prior orders regarding your representation.

Accordingly, please find enclosed a basic form of Attorney/Client Engagement Agreement (2 originals enclosed) for your consideration, signature and return to this office at your earliest convenience. If you prefer using a particular form of your own, please fill in the essential information (the stated service and rate shown) and submit for consideration.

In addition, a review of your billings from January 1, 2010 to date indicates that you have been billing for matters other than the *Heckman* case and the (now concluded) *Hutto Citizen Group, et al* case. Specifically, that review indicates you have been billing for matters related to the McGuyer-Lee claims and you have not been approved by Commissioners Court for representation in that case nor is there any Commissioners Court-approved attorney-services agreement on that matter. A review of your invoices for "County Court at Law Judge's Litigations Acct. 2394-014" indicates that you have billed and been paid by the County a sum total of at least \$ 4.256.08 for apparent work on the McGuyer-Lee claims and these are billings that should not have been paid for the reason that there is no Commissioners Court-approved order approving your representation of the individual County official you represent in the McGuyer-Lee matter. For these reasons, it is requested that you contact Julie Kiley in the Auditor's office to review the billing and verify the amount. Upon verification of the amount please issue a check or credit memo to Williamson County mailed to me at this office.

Thank you for your attention to these matters.
