ARTICLES OF INCORPORATION

OF

MEXICAN AMERICAN RESOURCES IN ACTION (MARIA) – LEADERSHIP DEVELOPMENT

(A Non-Profit Corporation)

I, the undersigned natural person of the age of eighteen or more, acting as incorporator of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the corporation is MEXICAN AMERICAN RESOURCES IN ACTION (MARIA) – LEADERSHIP DEVELOPMENT.

ARTICLE TWO

The corporation is a non-profit corporation and shall have no capital stock.

ARTICLE THREE

The period of its duration is perpetual.

ARTICLE FOUR

The corporation is organized exclusively for charitable, educational and social purposes, including for such purposes as:

 Receiving, investing, and disbursing funds, and holding property, for the purposes of the corporation aforesaid;

- (2) Conducting other activities, not in contravention of the Texas Non-Profit Corporation Act or ARTICLE SIX of these Articles of Incorporation, necessary or appropriate to carry out the foregoing purposes; and
- (3) Qualifying as a corporation excempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue laws).

ARTICLE FIVE

Except as these Articles otherwise provide, the Corporation has all the powers provided in the Texas Non-Profit Corporation Act. Moreover, the Corporation has all implied powers necessary and proper to carry out its express powers.

ARTICLE SIX

No part of the income or principal of the funds or property of the corporation shall ever inure to the benefit of any shareholder, member, director or officer of the corporation, or to any other private persons, except that reasonable compensation may be paid for services rendered to or for the corporation in connection with effectuating one or more of its purposes. No part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distributing of statements), any political campaign on behalf of or in opposition to any candidate for public office; nor shall the corporation engage in any activities which are unlawful under the laws of the United States of America or the State of Texas or any other state. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activity not permitted to be carried on (i) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any

future United States Internal Revenue law) or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law). Upon dissolution of the corporation, all assets of the corporation, after satisfaction or provision for satisfaction of debts and claims, shall be distributed, transferred and delivered as soon as practicable to or for the benefit of one or more organizations or societies which are organized and operated exclusively for charitable, religious, scientific or educational purposes and which are exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, or other corresponding provisions of any future United States law, to be used for the exempt purposes of such organization or organizations.

Without limiting the generality of the foregoing, the corporation:

- (1) Will distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code;
- (2) Will not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code;
- (3) Will not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code;
- (4) Will not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code; and
- (5) Will not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code.

ARTICLE SEVEN

The Corporation will have one or more classes of members as provided in the Bylaws.

ARTICLE EIGHT

The street address of the initial registered office of the corporation is 1802 Romford Drive, Austin, TX 78704 and its initial registered agent at such address is Margaret J. Gomez.

ARTICLE NINE

The management of the corporation is vested in its Board of Directors and such committees of the Board that the Board may, from time-to-time, establish. The Bylaws will provide the qualifications, manner of selection, duties, terms and other matters relating to the Board of Directors.

The number of Directors may be increased or decreased by amending the Bylaws. The number of Directors constituting the initial Board of Directors of the Corporation is three (3) and the names and addresses of the persons who are to serve as the initial Directors are as follows:

ARTICLE ELEVEN

A director of the corporation shall not be liable to the corporation for monetary damages for an act or omission in the director's capacity as a director, except that this ARTICLE ELEVEN does not eliminate or limit the liability of a director to the extent the director is found liable for:

- (1) A breach of the director's duty of loyalty to the corporation;
- (2) An act or omission not in good faith that constitutes a breach of duty of the director to the corporation or an act or omission that involves intentional misconduct or a knowing violation of the law;
- (3) A transaction from which the director received an improper benefit, whether or not the benefit resulted from an action taken within the scope of the director's office; or
- (4) An act or omission for which the liability of a director is expressly provided by an applicable statute.

ARTICLE TWELVE

The corporation shall indemnify persons for whom indemnification is permitted by Article 1396-2.22A of the Texas Non-Profit Corporation Act to the fullest extent permissible under such Article, and may purchase such indemnification insurance as the Board of Directors from time to time shall determine.

ARTICLE THIRTEEN

All references in these Articles to statutes, regulations or other sources of legal authority refer to the authorities cited, or their successors, as they may be amended from time to time.




