Yes- we completed the Deferred Prosecution agreement paperwork this last Wednesday (4/6/16). The terms of the Deferred Prosecution were exactly what we discussed in my office- I would not lower it:

2 years Def. Pros. + CES/Recs (Domestic Violence + 16 hrs. of parenting classes/counseling) + stay away/no contact with you, except per court ordered child custody agreement.

CES/Recs means he has to be evaluated for domestic violence and follow/complete the recommended classes.
