Synopsis:

No Contact Order Violation

On the above date and time I was contacted by Christa Lumus, Christa was the victim on a domestic assault case on 12-29-00. Officer Brown was the Initial Officer. Christa had been assaulted by her husband Jack Lumus.

Christa told me that after Jack had been taken to jail that night, he called her twice once at approx. 0330 hrs on the morning of 12-30-00, and again at approx 0400 hrs. Jack asked Christa for a phone number, and also asked her if she would come and bail him out.

Christa reminded Jack that he was in violation of the no contact order, and Jack told her that "he knows".

I checked, and the South Jordan Police did not issue a no contact order, so I called the salt Lake Co. Jail, and asked if they had. They have a copy of a no contact order that Jack Lumus signed at 0201hrs. on 12-30-00. The no contact order is good until 01-02-01.

I was not able to contact Jack Lumus due to the fact that **according to Christa he has left the state, and went to Colorado.**

I had the jail send me a copy of the no contact order, and I am going to screen this case with the Salt Lake District Attorney.

DISPATCH:

On December 29, 2000 at 2355 hrs I was dispatched to 11032 south Shilling Avenue apartment 1422 on report of a domestic violence. The complainant, Pam Webb, was calling from Texas and stated that her daughter, Christa Lumus, had called her and told her that her husband, Jack Lumus, had just hit her. Webb lost contact with Christa and had not been able to regain phone contact since.

ARRIVAL:

Upon arrival Officer Dempsey and I made contact at the door. Both parties met us at the door. Christa was crying and I could tell that Jack had been drinking by the odor of alcohol on his breath. I had Jack step out side so that we could talk. He did so willingly. Officer Dempsey went inside and spoke with Christa.

JACK'S STATEMENTS:

Jack told me that about an hour prior Christa had picked him up at a bar. The two of them began to argue in the car. Christa's young daughter was in the car when they were arguing. Christa and Jack both stated that she had gone to bed as soon as she arrived at the apartment. Upon arrival at the apartment the couple continued to argue. Christa had taken the keys to the motorcycle and Jack wanted them back. Jack was planning on leaving and walk to a friend's house to stay the night. As he was leaving Jack took Christa's purse. He stated that he felt it was a fair-trade, her purse for his keys. Jack also unplugged the phone and took the battery from the cordless phone. He told me that he was doing it just to get back at her for taking his keys. As Jack was headed to the door Christa grabbed him to get her purse back. She later told me that she was grabbing at his arm and shoulder, and the purse. Jack stated that he did not push her at all. He told me that Christa just wanted her keys from the purse so he gave them to her. He then left the house with the purse. Jack told me that while at his friends he began to feel bad and decided to return the purse to Christa at the apartment. When he returned the couple began to argue again. We arrived shortly thereafter.

CHRISTA'S STATEMENTS:

Christa told Officer Dempsey and me the same story except that when they were struggling at the door for the purse that Jack had pushed her back away from him. There were some red marks on Christa's arms. Christa also said that she had to physically remove her keys from the purse before Jack took it. She also said that he threatened her saying that he would kick her ass. Christa also told me that Jack had said that he was taken

the phones apart so that she wouldn't call 911.

DISPOSITION:

I arrested Jack for Damage to a communication device and intoxication. I placed him in handcuffs and double locked them. Due to his intoxicated state I did not feel comfortable letting him go to a friends house. I also spoke with Sgt. Larsen who suggested that I book Jack in the adult detention center on the charges. I searched my patrol vehicle before and after I transported Jack. Jack was released to the adult detention center. I issued a citation to Jack and had it placed with his other property in the adult detention center. Christa was left at the scene and was contacted by the victims advocate to find her another place to stay for the night.

Narrative:

I was dispatched to assist Officer Brown on a domestic at the Sterling Village Apartments. I have responded to this address before on the same type of call. Officer Brown and I arrived and made contact with the victim. She was crying and obviously upset. We separated the two parties involved. Officer Wimmer also arrived to assist. The victim, Christa showed me some red marks on her right arm. She said that they were from the fight. It appeared that her skin was red from being scratched slightly. Officer Brown interviewed the suspect, Jack. I asked Christa if she wanted for me to call the victims advocate out. She initially refused. Sgt. Larsen arrived and assisted. Officer Brown decided to take Jack into custody. He handcuffed Jack while myself and Officer Wimmer assisted. Sgt. Larsen told Christa that we would have the victims advocate call her on the phone. I contacted the victims advocate and updated her on what had happened recently. She said that she would call and talk with Christa. Sgt. Larsen told Christa that she should come down to the police station in a couple of days to take pictures of any bruising that might show up. Christa agreed.

Approximately an hour later the victims advocate called me back. She told me that Christa was going to stay in the house for tonight and her mother was going to drive to Utah from Texas and help her move back to Texas.

Narrative:

I was dispatched to a domestic dispute in progress at 11032 South Shilling Ave #1422. Dispatch advised me that it was physical and the male party had been drinking. Officer Brown was dispatched to assist.

I arrived at the house approximately 2 minutes after receiving the call. I could not hear any arguing from outside. I knocked on the door and the victim, Christa answered the door. She was on the phone with the dispatcher. She hung up the phone and started to tell me what happened.

She told me that she and her husband Jack were in a verbal argument. She said that he had been drinking and was out at a bar with some of his friends. She told me that they were yelling and he placed his hand over her mouth. In Christa's statement she states that Jack said "Look you fucking bitch be quiet." I asked her if he had hit her at all. She said he didn't. She said that he was passed out on the chair in the living room. I walked into the living room and saw him sitting in the chair. Christa said that when Jack had put his hand over her mouth she pushed him away. She said that he fell into the computer that was also in the living room.

When Jack saw me he stood up and said "Take me to jail officer." I told him that I was not there to take him to jail. He then said that he wanted to leave and go to a friends for the evening. I asked him where that was and he told me that I did not need to know. I told him that he should not drive. He said that he was going to walk. Jack and Christa started to argue again. I told Jack that I would call him on his cell phone later after he cooled off. At that point Officer Brown arrived.

I had Christa complete a statement form while I completed the domestic violence paperwork. Sgt Larsen arrived and suggested that Jack be located. Christa gave Sgt. Larsen and Officer Brown directions to a couple of apartments that Jack might be at. They looked without any success. While they were looking for Jack I contacted the Victims Advocate and asked her to respond. She said she would arrive at the residence in 20 minutes.

I called Jack on his cell phone and asked him where he was. He said that he was at his friends house. I asked him where that was and he would not tell me. He said that I wanted to take him to jail. I told him that I could issue a citation and let him go. He asked why I wanted to see him. I told him that I wanted to get his side of the story. He said that he knew what his rights were and that he did not want to say anything without an attorney. I asked him if he wanted to tell his side

of the story. He told me that he and his wife were arguing. They lived in a corporate owned apartment and they have co-workers living above them. He said that he gets in trouble every time he and his wife get into an argument. They were yelling at each other. Jack then told me that he put his hand over her mouth to try and keep her from yelling. I again asked him where he was and he told me that I can come arrest him but he refused to tell me where he was. I told him that I would issue a citation and he would appear in court on Monday. He said that he did not have time to go. He again said that he would rather spend the weekend in jail. I asked him again where he was and he again refused. I told him that he was not allowed back in the house. I told him that Christa will call the police if he shows up. He then told me that if I wanted to talk to him I was going to have to get a warrant. He then hung up.

As I was talking with Jack the Victim Advocate arrived. She met with Christa and I went outside to complete my paperwork. The Victims Advocate came out and told me that Christa was going to come in on Monday and talk to the city attorney. This case will be filed with the city attorney.

DISPATCH:

On December 16, 2000 at 300 hrs I was dispatched to assist Officer Dempsey on a domestic violence call. The narrative stated that it was physical and that the male party was intoxicated.

ARRIVAL:

When I arrived on scene I noticed a male party leaving the area of the apartment. I then noticed Officer Dempsey following him out. Officer Dempsey told me that the male party was going to go spend the night somewhere else. Officer Dempsey also told me that the female party had told him that it had not been physical.

INTERVIEW:

I then went inside and began talking with the female party. I asked her if it had been physical. She stated it had been the male party had held her down in a chair and had covered her mouth with his hand. I then informed Officer Dempsey of this.

LOCATION OF MALE:

Sgt. Larsen and I then checked some of the apartments in the area, which the female stated that the male might be going to spend the night. We could not locate him.
