PBS&J completed initial preliminary engineering services on the Barton Creek Lift Station Force Main and the Robert E. Lee Interceptor Rehabilitation Projects in March 2002. In August 2002, the Water & Wastewater Utility contracted with PBS&J to perform additional preliminary engineering services for the Barton Creek Lift Station Force Main Project.

The project location occupies a large area of Archeological Site 41TV1364. The additional services included investigation on appropriate design and construction methodologies in this work area. During this period, meetings were held with stakeholders of the Zilker Park/Barton Springs area to: a) report on the state of the existing system, b) provide information regarding proposed improvements, and c) receive feedback on proposed project implementation.

During the extended preliminary engineering period, sufficient information was obtained to answer questions on design and construction methodologies to the satisfaction of Water & Wastewater Utility staff. Also during this period, productive meetings were held with various stakeholder groups regarding the progress of this project. The Utility is ready to proceed with the project.

This amendment will provide for design phase services of the professional services agreement.


