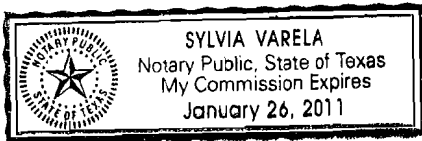

# Tide of Grassroots Support Lifts Barton Campaign Fundraising

More than 500 people, most of them small donors, helped Hays County Commissioner Jeff Barton to a "highly successful" fundraising period, his campaign announced today.

With fundraising and expense reports due July 15, Barton released his financial reports as required by law this week. In the spirit of transparency, he also provided the press and public with additional disclosure.

The campaign raised \$42,587.50 in the first six months of 2009, with a median contribution of \$40.

"I'm extremely proud of the broad-based support," Barton said in a prepared statement. "It's a group effort. We have a lot to do in this county -- water, transportation, planning for growth."

Most of Barton's contributions came from two events this spring where the campaign reported more than 500 people attended. Not every one of those donated directly: some were family members with tickets paid for by a head of household, or came as guests of donors who sponsored tables.

Direct donors for the period of Jan. 1 - June 30 totaled between 250 and 260 people and groups, Barton said. (The campaign used a range because some ticket sales at the door for \$40 or less did not indicate whether spouses or other adult guests wished to be listed as a donor. For calculating median donations, the campaign assumed 254 donors.)

The State of Texas does not require campaigns to list the number of people who give \$50 or less, or to call out Political Action Committee (PAC) contributions, but Barton's campaign did. It reports that slightly more than 90 percent of all donations came from individuals. Under 10 percent came from PACs.

It lists details on 124 cash contributors and three in-kind contributors who all gave more than \$50, and reports its estimate of 127 donors of \$50 or less.

Donations came from every zip code in Hays County, including significant contributions from the areas of Buda, Kyle, San Marcos, Wimberley, Driftwood, Dripping Springs and Austin.

The median donation was exactly \$40, meaning half of all donors gave that amount or more; half gave that amount or less.

Barton was elected in 2006 and took office in 2007. His term expires in 2010. He said he has "broad based fundraising plans" for this fall. "It's harder to build a grass roots campaign like this one," Barton said. "But in the end it's worth it."

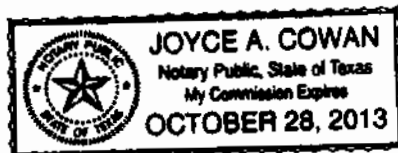

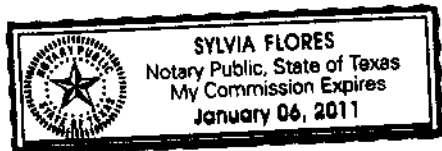

Jan. 15, 2010 -- Nearly 400 individuals donated to the Jeff Barton Campaign in 2009, according to filings released by the campaign today.

As it has done before, the Barton campaign went beyond what the law requires in its financial disclosure.

The filings for the last six months of 2009 show a median donation of less than \$10, with total donations of \$10,995.31.

In the first six months of the year -- including two large fundraisers -- the campaign reported raising \$42,587.50, with a median contribution of \$50.

That makes total contributions for 2009 of \$53,582.81.

Barton announced for Hays County Judge Jan. 4, and the campaign will not report funds raised since then until the next state reporting period, 30 days prior to the March 2 election. The current campaign contribution and expenditure reports cover the period through Dec. 31, before Barton -- a sitting county commissioner -- had formally announced.

"I'm really pleased that we're in such good financial condition," said Barton. "I'm particularly proud that we have so many small contributors and such a broad-based, grassroots campaign, with donors from every community in Hays County."

Barton said the strong fundraising results, even though he was not yet a candidate for county judge, give him a head start in the judge's race and will allow him to run a vigorous county-wide campaign.

"If you look at the number of donors, and the diversity of the people who are giving, and then you consider how many volunteers have stepped forward, you have to feel good about where we are," Barton said. "Since I announced for judge, donations and volunteers have really picked up -- something we'll be excited to show in our next reports."

Donations for July through December, the period covered in the reports filed today, show 112 people gave \$50 or less, and 128 total contributions. The campaign said the smallest donation was \$5, the largest \$2,000.

Total donors for the year are at least 382 -- probably more because some contributions shown as single individuals were actually families or couples.

"We've got a lot more small donors than big donors, but we're pretty strong in both categories, really," Barton said. "This is a Democratic campaign fueled on people power. We know how to be competitive -- and know how to win."
