Ms. Delgado:

After reviewing the documentation you left with me, I am afraid there is nothing I can do to help you.

The Notice of Judicial Clemency form you left refers to Texas Code of Criminal Procedure, Article 42A.701. This is a procedure for a defendant to request an early discharge from probation after successfully completing all the requirements of that probation. That is not the case here. Your case has long been over with, and you did not successfully complete that probation. This court lost any jurisdiction it may have had almost seven years ago. I no longer have any authority to issue any kind of order regarding this matter. Even if I still had any jurisdiction of this case, I could not sign an order stating that you successfully completed your probation, as it was revoked.

The only remaining avenue that I am aware of to have this removed from your record would be a governor's pardon. I am unaware of anything a trial court judge can do once the matter is final.

Again, I am sorry, but there is nothing I can legally do to help you in this matter.
