On December 1, 2022, Mayor Steve Adler violated Tex. Elect. Code, Title 15, section 255.003(a) by using City of Austin resources, e.g., ATXN staff, equipment, website, to record and advertise a press conference in which Mayor Adler engaged in political advertising (as defined by Tex. Elect. Code section 251.001(16)) to endorse candidates in the December 13, 2022 Council election runoff, to wit, Zo Qadri in District 9 and Jose Velasquez in District 3. Mayor Adler's use of city resources to make the endorsement is a Class A Misdemeanor pursuant to Tex. Elect. Code section 255.003(c). Section 255.003 (a) says:

Sec. 255.003. UNLAWFUL USE OF PUBLIC FUNDS FOR POLITICAL ADVERTISING. (a) An officer or employee of a political subdivision may not knowingly spend or authorize the spending of public funds for political advertising.

Political advertising is defined in Tex. Elect. Code:

Sec. 251.001(16) "Political advertising" means a communication supporting or opposing a candidate for nomination or election to a public office or office of a political party, a political party, a public officer, or a measure that:

(A) in return for consideration, is published in a newspaper, magazine, or other periodical or is broadcast by radio or television; or

(B) appears:

(i) in a pamphlet, circular, flier, bil board or other sign, bumper sticker, or similar form of written communication; or

(ii) on an Internet website.

A review of the video and transcript of Mayor's Adler press conference reveals that only about 15% of the conference was to encourage the public to go vote in the runoff election. About 10% of the conference was spent by Mayor Adler denouncing a petition drive related to police oversight. About 30% of the conference was spent making the political endorsement of Zo Qadri and Jose Velasquez. The remaining 45% of the conference was spent on Mayor Adler's dual endorsement of Kirk Watson and Celia Israel for Mayor. At the end of the video, it lists the City staff involved in producing the press conference, including Associate Producer Eric Cruz, Chief Engineer Garry Wildison, Engineering Mark Batchelder, Tom Dynia, Oscar Palomo, Master Control/Programming Robert J. Heath, Executive Producers Jessica King, and Keith Reeves. The video ends saying: "This is an ATXN Production @ 2022, All Rights Reserved."

In Tex. Ethics Advisory Opinion No. 550 at 3 (Jan. 28, 2019), the Commission warned that:

The 'spending' of public funds includes the use of a political subdivision employee's work time or a political subdivision's equipment or facilities. 'Political advertising' is defined, in pertinent part, as a communication supporting or opposing a candidate for nomination or election to a public office....

The Texas Ethics Commission has also warned that, "The city's production of an event deliberately designed to provide a platform for the dissemination of political advertising is therefore prohibited by section 255.003." Tex. Ethics Advisory Opinion No. 563 at 4 (Sept. 1, 2021). Likewise, the Commission has held:

It is not possible, however, to state that comments by city council members at a recorded public meeting could never give rise to a violation of section 255.003 because we can imagine a situation in which one or more city council members might arrange a discussion of a matter not pending before the city council with the hope that broadcasts of the discussion would influence the outcome of an election." Tex. Ethics Advisory Opinion No. 456 (July 16, 2004).

There can be no doubt that Mayor Adler intended this press conference to influence the outcome of the election. Using City resources to do so was criminal behavior.

Mayor Adler has the same free-speech rights as any other member of the public and the same access/restrictions to city resources as other members of the public for political purposes. But City staff, equipment, and website are not available for political advertising, such as candidate endorsements, to the general public or anyone. As a City official, Mayor Adler has control of certain city resources by virtue of his position. Mayor Adler misused his position as Mayor to commandeer city staff, audio-video equipment and website to engage in his own political endorsement of candidates. See "GUIDELINES FOR NON-CITY USE" of City Hall (located at https://www.austintexas.gov/sites/default/files/files/Guidelines_for_Non-City_Use_02.02.12.pdf) ("The City's media equipment is not available for public use." "City resources or equipment may not be used for election campaigning.").

On good faith belief, Complainant asserts that prior to his December 1, 2022 press conference Mayor Adler was warned by city legal counsel that Council members are not allowed to spend or authorize spending public funds for political advertising, and that prohibition includes using city equipment, computers, copiers, supplies, staff, postage, stationary, email, websites, twitter or other social media sites, bulletin or electronic message boards, resources, ATXN Channel 6, and the like. Mayor Adler was surely aware that this press conference was set up, recorded, and archived on the City's website in violation of the prohibition against political advertising.

Mayor Adler's use of city resources to make the endorsement is a Class A Misdemeanor pursuant to Tex. Elect. Code section 255.003(c).

ARE YOU GUYS PICKING UP THE SOUND YOU NEED? DO WHAT? AND ARE WE DOING OKAY? YEAH.

ALL RIGHT.

I'M GONNA START AGAIN.

TODAY IS THE FIRST DAY OF EARLY VOTING.

IT'S THE FIRST EARLY VOTING'S GONNA GO FROM THE FIRST TO THE NINTH, AND I WANT TO URGE EVERYBODY TO, UH, GET OUT AND VOTE.

UH, EACH OF THE RACES ON THIS BALLOT, UH, UH, COULD BE VERY, VERY CLOSE.

AND I'M HERE TO TELL EVERYBODY THAT EVERY VOTE IS GOING TO COUNT, AND EVERY VOTE IS EXTREMELY IMPORTANT IN THESE RACES.

YOU KNOW, AND OUR HISTORY VOTER TURNOUT DURING RUNOFF ELECTIONS HAS BEEN VERY, VERY SMALL.

I SAW, BY THE WAY, UH, THE PRESS CONFERENCE THAT WAS HERE A LITTLE BIT EARLIER, UH, ABOUT SOME, UM, UH, PETITION HUCKSTERS, UH, THAT ARE OUT TRYING TO GET PEOPLE TO SIGN, UH, PETITIONS, UH, REPRESENTING THEMSELVES TO BE SOMETHING DIFFERENT THAN WHAT THEY ARE.

I HOPE PEOPLE ARE, ARE SMART ENOUGH AND AWARE TO UNDERSTAND THAT THE PEOPLE THAT ARE OUT, UH, GATHERING PETITIONS ON POLICE OVERSIGHT ARE TRYING TO OVERTURN THE, THE ACTION THAT THE COMMUNITY TOOK EARLIER.

UH, AND, UH, UH, I'M HOPING THAT, UH, FOLKS DO NOT SIGN THOSE, UH, PETITIONS, AND I'M HOPING THAT THEY ARE NOT, UH, MISLED.

UH, I'M ABOUT TO GO VOTE.

SO I THOUGHT I'D GIVE, UH, YOU MY THOUGHTS ON, ON THE ELECTION AND, AND THE VOTING THAT'S ABOUT TO TAKE PLACE HERE.

UH, I AM IN, UH, DISTRICT, UH, NINE, UH, SO I'M GOING TO BE VOTING IN THE RUNOFF ELECTION TODAY FOR, UH, COUNCIL.

UH, I'M, I'M HAPPY TO SEE ZOE HERE TODAY.

UH, UH, HERE WE'RE GONNA VOTE TOGETHER.

UH, AND I WANT YOU TO KNOW THAT I AM VOTING FOR ZOE.

I'M VOTING FOR ZOE BECAUSE I THINK HE IS SMART, HE IS KNOWLEDGEABLE, AND HE IS FOCUSED ON THE ISSUES THAT I THINK ARE MOST IMPORTANT RIGHT NOW, AND THAT'S HOUSING COSTS AND, AND, AND EQUITY.

HE UNDERSTANDS THAT MEETING OUR HOUSING CRISIS BEGINS WITH LAND DEVELOPMENT CODE REFORM.

HE SPEAKS ABOUT PERMANENT SOLUTIONS TO HOMELESSNESS AND DOES NOT PANDER WITH PROMISES OF QUICK FIXES.

AND WHEN ADDRESSING OUR TRANSPORTATION FUTURE, HE LEADS WITH THE NEED FOR MOBILITY OPTIONS RATHER THAN OUR HISTORICAL FOCUS ON, ON HIGHWAYS AND STREETS AND CARS.

AND WHEN HE SPEAKS ABOUT PUBLIC SAFETY, HE ADDRESSES NEEDED POLICING REFORM.

HE DOESN'T CREATE, HE DOESN'T TRADE ON CREATING, UH, FEAR AND PROMOTING THE FICTION THAT OUR COMMUNITY IS NOT SAFE.

I BELIEVE THAT HAVING A DIVERSE AND EMPATHETIC VOICE ON COUNCIL IS CRITICAL TO US MEETING OUR BIGGEST CHALLENGES.

AND ZOE IS ALL OF THESE THINGS.

AND I AM EXCITED TO BE ABLE TO CAST A VOTE TODAY FOR ZOE IN THE DISTRICT NINE RUNOFF.

BY THE WAY, I CAN'T VOTE IN DISTRICT THREE.

I DON'T LIVE THERE, BUT, BUT IF I LIVED IN DISTRICT THREE, THEN I WOULD BE VOTING FOR JOSE, UM, VELASQUEZ, UH, BECAUSE OF HIS HISTORY OF COMMUNITY ORGANIZATION IN THAT DISTRICT, AND AGAIN, HIS RECOGNITION THAT ONE OF THE MOST IMPORTANT WAYS TO DEAL WITH RISING HOME PRICES IN OUR CITY IS THROUGH LAND DEVELOPMENT CODE REFORM.
